Dear Pharmacist and PMA

Funding for primary health care consultations available from 1 January 2020

We want to ensure that healthcare providers and members experience a seamless transition in claiming for clinic consultations under the new codes.

Due to the size and scope of this initiative, we are rolling out the video call network in phases - other telemedicine enablers and pharmacies will follow early in 2020.

From 1 January 2020, you can use the following code to claim for consultations for:

- Eligible employees of Discovery Primary Care
- Members of Discovery Health Medical Scheme for:
 - available day to day benefits
 - Day-to-day Extender Benefit

Please ensure that the following codes and rates are loaded onto your systems and software.

Once the video call network has been established, we will roll out Primary Care Drug Therapist (PCDT) and nurse consultations in clinic pharmacies participating in the Wellness Network. We will continue to keep you informed about our progress.
